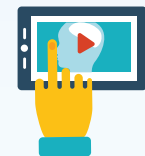

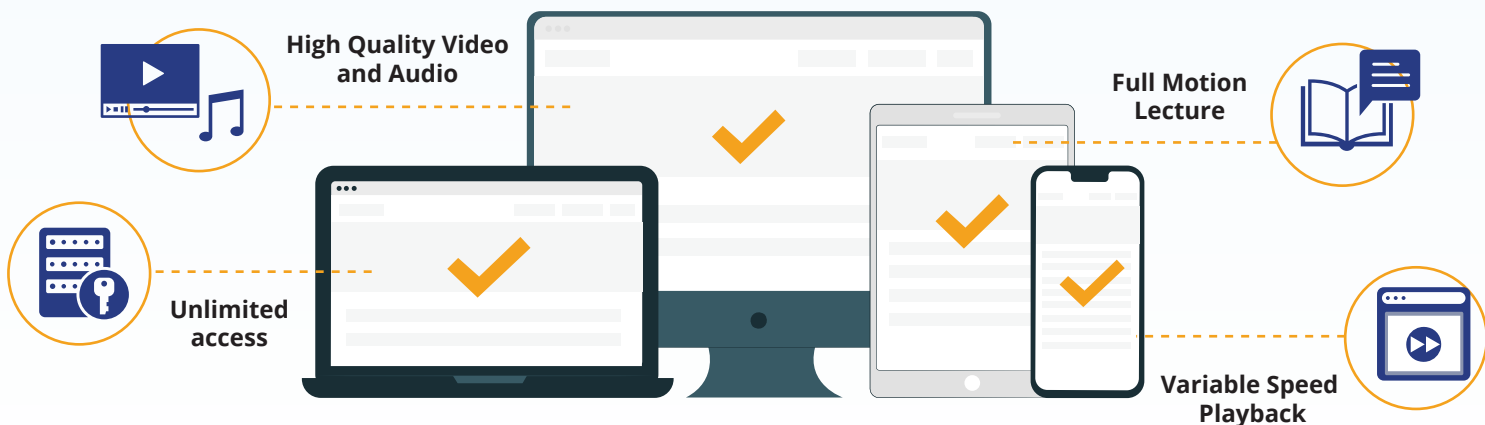

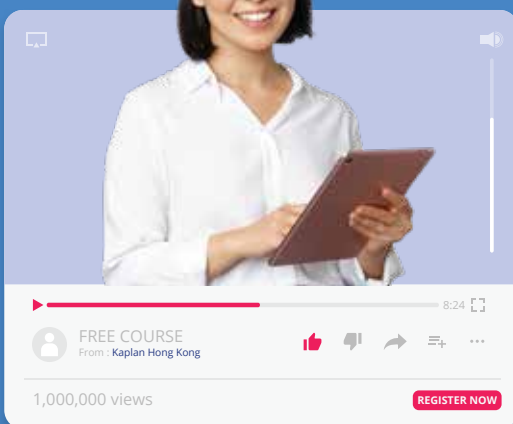

**Enrolment Policy**
